Re: In-Station Diagnostic (ISD) Technician Training and Registration

California's Enhanced Vapor Recovery (EVR) regulations require new stations built after September of 2005 to be equipped with an ISD system. Veeder-Root's ISD system was certified by the California Air Resource Board (CARB) on August 31, 2005. To be eligible to startup an ISD system technicians must complete an ISD training course.

Among other topics, ISD technician training seminars include Installation, Checkout, Startup Programming, Operations Training, Troubleshooting and Service Techniques. A fee of \$100 will be assessed per seminar per student.
